I am excited to have your team competing in the 2nd Annual Mr. Basketball & Miss Basketball Minnesota Showcase. The 2010 Minnesota Showcase will feature 44 teams from five states, including South Dakota, North Dakota, Iowa, Minnesota and Wisconsin.

DEADLINE FOR ROSTER CHANGES & ADDITIONS:

Team rosters will become final at noon on Monday, June 14. Changes will not be allowed after this date. It is mandatory that all players submit a completed Player Profile Sheet and Parent Release Form to be eligible to participate, including any additions made to your roster between now and June 14.

TO ADD A PLAYER to your roster, the athlete must complete a player profile sheet (available on website) and fax it to me at 501-421-6490.

If you have any player deletions or jersey number changes, please e-mail them by the June 14 deadline so the appropriate changes can be made in our college coach packets and the official scoresheets.

Enclosed you will find the pool play and tournament schedules and a list of **notes & reminders** that contains a great deal of important info.

Teams should arrive at the Taylor Center about one hour before your first game and our staff will provide you with player/coach passes and any additional information you will need. Please remember that your parent release forms must be turned in upon arrival (if not previously submitted).

Please carefully locate all three of your pool games on the schedule and note that all game times are Central time. In pool play, the home team is the second team listed in each pair on the schedule, will wear light colored jerseys and sit to the left of the scorekeeper facing the court. In bracket play, the home team is the bottom team in the bracket, will wear light colored jerseys and sit to the left of the scorekeeper facing the court. It's mandatory that teams bring both sets of uniforms to the gym to avoid any problems (not physically in the gym, but at least in the coaches car so they are quickly accessible).

I hope that you enjoy the tournament and your stay in Mankato. Let's try our best to encourage sportsmanship and a friendly atmosphere among the players and coaches.

MINNESOTA SHOWCASE NOTES & REMINDERS

1. The gym will open at approximately 8:15 AM each morning.
2. Each player will be given a tournament pass for admission each day. This pass must be displayed to access the gym. **Passes will be strictly enforced.**
3. A maximum of two team coaches will be fitted with a wristband that will admit them to the gym each day. Additional coaches, bookkeepers, bus drivers, etc., will be required to pay the daily admission. Make sure your players have their passes, our staff will not allow anyone to enter without a pass, wristband, or paid admission.
4. We will allow only two coaches, one bookkeeper and the players on the floor during the game. Team bookkeepers WILL NOT be allowed to sit at the score table, they must sit on the team bench. No other individuals will be allowed on the team bench, this includes administrators, parents, members of other teams in the program, younger siblings, etc.
5. **UNIFORM ASSIGNMENTS:** In Pool Play, the home team is the second team listed in each pair on the schedule, will wear light colored jerseys and sit to the left of the scorekeeper facing the court. In Bracket Play, the home team is the bottom team in the bracket, will wear light colored jerseys and sit to the left of the scorekeeper facing the court. **Teams are required to bring both sets to the gym in the event any changes must be made (at least available in a coaches vehicle).**
6. A trainer will be on duty throughout the tournament. Players who need taped must bring their own supplies. **The school & tournament will not provide supplies.**
7. All players must have submitted a **Player Profile Sheet and Parent Release Form** before they will be allowed to play, this includes roster additions.
8. **Games will start on time, or a little early if possible.** In most cases warmups will be the length of time between the end of a game and the scheduled start of your game.
9. Lockerrooms will be available for changing, showering, etc. DO NOT leave anything in the lockers, take everything to your bench. Leave valuables at the motel, the tournament staff can not be responsible for lost or stolen items.
10. Teams must leave the bench area **immediately** after their game; post game discussions should be held in the hallway or outside. Please pickup your water bottles and other trash before leaving the bench area.
11. **GAME RULES:** Games will consist of two-16 minute halves (stop-clock). No bonus free throws will be shot during the first half, shooting fouls will be though. Teams will enter the bonus on the 7th team foul of the second half, no two shot bonus on the 10th foul. Each team receives 3 timeouts per game. Overtime will be two minutes, each team receives one timeout during overtime (no carryover from regulation). Halftime will be 3 to 5 minutes, this will be the decision of the director and floor staff. There are no regulations on defenses or playing time.
12. Tie breaker for seedings is determined by head-to-head competition in a two-way tie. A three-way tie is broken first by determining the team with the highest average margin (20 point cap per game) for all three games, this team receives the high seed. The remaining two-way tie is broken by the results of head-to-head competition.
13. Spalding is the official game ball; tournament supplied basketballs must be used for all games. **Bring your own basketballs for warmups.**
14. **MSU WILL NOT HAVE CONCESSIONS AVAILABLE. Plan accordingly for water, etc.**
